Objective and rationale, including the nature of urgent problems where applicable: In order to ensure the quality, safety and efficacy of health products, the FDA, through the Center for Cosmetics and Household/Urban Hazardous Substances Regulation and Research; continuously reviews standards applied for the proper evaluation of pesticide products. Furthermore, the FDA shall constantly adhere and promote agreements local and international conventions, in the ban or restriction of ingredients used in the manufacture of household pesticide. In view of these, to provide an easy reference to HUP establishments securing

amend FC 2017-005 and FC 2017-015 by providing a consolidated list of banned and restricted pesticides.; Protection of human health or safety
