Title of Legislation: Technical Regulation of Electric vehicle supply equipment Primary Content:

- (1) (Grade Subdivision) The differentiation of products exhibiting exceptional weighing performance through the subdivision of tolerance grades.
- * Alternating Current (AC): Previously within $\pm 1.0\%$ (single class), now subdivided into 0.5 class ($\pm 0.5\%$), 1.0 class ($\pm 1.0\%$) (two classes).
- * Direct Current (DC): Formerly within $\pm 2.5\%$ (single class), now subdivided into 0.5 class ($\pm 0.5\%$), 1.0 class ($\pm 1.0\%$), 2.5 class ($\pm 2.5\%$) (three classes).
- (2) (Deregulation) Streamlining of testing parameters unrelated to weighing performance.

- * (E.g) for minor software(SW) function modification: (Previous) change approval after necessitating SW identification, (current) it is reduced to a notification process only.
- (3) (Clarification of Terms): Enhancement of technical regulation clarity through precise terminology rearrangement.
