The following communication, received on 22 July 2024, is being circulated at the request of the Delegation of the <u>Kingdom of Saudi Arabia</u>.

Notice of Administration Order of Saudi Food and Drug Authority Ref. No. 11808 dated 6 December 2022 entitled "Temporary ban on importation of poultry meat, eggs and their products originating from Finistère, Mayenne and Côtes-d'Armor in France"

The Saudi Food and Drug Authority (SFDA) issued the Notice of Administration Order of Saudi Food and Drug Authority Ref. No. 11808 dated 6 December 2022 entitled "Temporary ban on importation of poultry meat, eggs and their products originating from Finistère, Mayenne and Côtes-d'Armor in France". The Saudi Food and Drug Authority (SFDA) has subsequently issued the Notice Administrative Order No. 2128 dated 18 July 2024, lifting the temporary ban on the importation of poultry meat, eggs and their products originating from Côtes-d'Armor in France, based on the WOAH report dated 14 August 2024, indicating that Côtes-d'Armor in France is free of Highly Pathogenic Avian Influenza Virus (HPAI).
