The following communication, received on 22 July 2024, is being circulated at the request of the Delegation of the <u>Kingdom of Saudi Arabia</u>.

The Saudi Food and Drug Authority (SFDA) issued the Notice of Administration Order of Saudi Food and Drug Authority Ref. No. 27385 dated 22 May 2023 entitled "Temporary ban on importation of poultry meat, eggs and their products originating from Landes and Gers in France". The Saudi Food and Drug Authority (SFDA) has subsequently issued the Notice Administrative Order No. 2128 dated 18 July 2024, lifting the temporary ban on the importation of poultry meat, eggs and their products originating from Landes and Gers in France, based on the WOAH report dated 14 August 2024, indicating that Landes and Gers in France are free of Highly Pathogenic Avian Influenza Virus (HPAI).
