Title, number of pages and language(s) of the notified document:</b> Draft Commission implementing Regulation amending and correcting Implementing Regulation (EU) 2021/1165 authorising certain products and substances for use in organic production and establishing their lists; (10 page(s), in English), (20 page(s), in English)
<b>6. Description of content:</b> This draft Commission implementing Regulation amends in its annexes the lists of products and substances authorised to be used in organic production, in particular: plant protection products, fertilisers, feed material, feed additives and food additives and processing aids. It also includes new specific lists for substances and products authorised for use in organic production in third countries and in the outermost regions of the Union pursuant to Article 45(2) of Regulation (EU) 2018/848.
<b>7. Objective and rationale, including the nature of urgent problems where applicable:</b> The corrections and amendment of the lists of products and substances are based on requests for new uses and correction of specifications and listing in line with horizontal rules. By amending its annexes, this draft Commission implementing Regulation aims to contribute to consumer confidence and protection, as well as to ensure that production processes do not harm the environment, human health, plant health or animal health and welfare; Quality requirements
