Description of content:** This draft Commission Regulation concerns the refusal of authorisation of a health claim made on foods and referring to the reduction of disease risk in accordance with Article 17 of Regulation (EC) No 1924/2006 of the European Parliament and of the Council of 20 December 2006 on nutrition and health claims made on foods.
- 7. Objective and rationale, including the nature of urgent problems where applicable: The proposed measure is a draft Commission Regulation for one health claim as referred to above under point 6 that has been assessed by the European Food Safety Authority (EFSA) with an unfavourable outcome. Therefore, the health claim included in this draft Commission Regulation does not comply with the conditions set out in Regulation (EC) No 1924/2006 and will not be authorised.; Protection of human health or safety
