Description: Regulation of The Minister of Industry Number 22 of 2025 amends The Regulation of Minister of Industry Regulation Number 64 of 2024 on The Mandatory Implementation of Indonesian National Standard for Hot Rolled Steel Sheets, Plates, And Coils, and Cold Rolled Steel Sheets and Coils.

Several provisions in Minister of Industry Regulation No. 64 of 2024 have been amended.

- **Article 2** is amended to stipulate the enforcement of:
 - SNI 8522:2024 for Bj PS (hot rolled sheet steel),
 - SNI 8784:2024 for Bj PL (hot rolled plate steel), and

- SNI 3567:2024 for Bj D (cold rolled steel).

- **Article 64 paragraph (3)** is amended to read:

"The product certificate for the use of the SNI mark for hot rolled steel sheets, plates, and coils and/or the product certificate for the use of the SNI mark for Bj D must be adjusted in accordance with the provisions of this Ministerial Regulation no later than **20 May 2026**."

- **Article 64A** is inserted between Articles 64 and 65, and reads:

"(3) The SNI Certificate and SPPT SNI for Bj PS and/or Bj PL, as well as the SNI Certificate and SPPT SNI for Bj D, shall become effective as of the date of issuance of the respective SNI Certificate and SPPT SNI."

- **Article 66 paragraphs (3) and (4)** are amended to state:

"Hot rolled steel sheets, plates, and coils and/or Bj D produced domestically and manufactured up to 20 May 2026 may continue to be circulated until reaching the end user.

Imported hot rolled steel sheets, plates, and coils and/or Bj D that have completed customs clearance by 20 May 2026 may also continue to be circulated until reaching the end user."

- **Article 67A** is inserted between Articles 67 and 68, and reads:

"(3) In the case of Brand Cooperation or Maklun (contract manufacturing):

a. An industrial company or overseas producer through an Official Representative receiving the Brand Cooperation or Maklun may apply for the issuance of an SNI Certificate for Bj PS, Bj PL, and/or Bj D; and

b. The industrial company providing the Brand Cooperation, the Official Representative of the overseas producer providing the Brand Cooperation, the business actor providing the Maklun, or the company representative of the overseas business actor providing the Maklun may apply for the issuance of SPPT SNI for Bj PS, Bj PL, and/or Bj D."

- **Article 69** is amended to read:

"This Ministerial Regulation shall enter into force on **20 May 2026**."
