**Title:** Draft decree of Ministry of Industry on Mandatory Indonesian National Standard for SNI 07-2053-2006 Zinc coated steel sheet (available in Indonesian language).

**Description:** Regulation of the Minister of Industry of the Republic of Indonesia Number 23 of 2025 amends the Regulation of the Minister of Industry Number 67 of 2024 on the Mandatory Implementation of the Indonesian National Standard for Zinc-Coated Steel Sheets and Color Zinc-Coated Steel Sheets.

Several provisions in Minister of Industry Regulation No. 67 of 2024 have been amended.

- Article 2 paragraphs (2) and (4) are amended to stipulate the enforcement of
  - o SNI 2053:2024 applies to **Bj LS** (Zinc-Coated Steel Sheets)
  - SNI 66:2024 applies to Bj LSW (Color Zinc-Coated Steel Sheets)

- Article 64 paragraph (3) has been amended to read:

Product certificates previously issued under Regulation No. 38/M-IND/PER/2/2012 are recognized as valid SNI and SPPT SNI certificates. However, these certificates must be adjusted to comply with the provisions of the current Ministerial Regulation no later than **20 May 2026**, and will take effect as updated certificates starting from that date.

• Article 64A is inserted between Articles 64 and 65, and reads:

In cases where product certificates issued under Regulation No. 38/M-IND/PER/2/2012 expire before **20 May 2026**, businesses are permitted to submit applications for new **SNI and SPPT SNI certificates** for **Bj LS**. The newly issued certificates will become effective as of their respective issuance dates.

• Article 66 paragraphs (2) and (3) are amended to state:

It is stipulated that **domestically produced Bj LS**, manufactured no later than **20 May 2026**, may continue to circulate until it reaches the end user. Similarly, **imported Bj LS** that has completed customs clearance by the same date may also remain in circulation until it reaches the end user.

• Article 67 amended to include provisions for products that were not previously regulated.

Accordingly, **Bj LS** that was not covered under Regulation No. 38/M-IND/PER/2/2012 but conforms to **SNI 2053:2024**, is now subject to compliance with the current Ministerial Regulation. Furthermore, **Bj LS and Bj LSW**, whether domestically produced or imported by **20 May 2026**, may continue to circulate in the market until they reach the final user.

- Article 67A is inserted between Articles 67 and 68, and reads:
  - Overseas manufacturers may apply for SNI certificates for Bj LS and/or Bj LSW through an official representative.
  - Domestic manufacturers or official representatives are eligible to apply for SPPT SNI for the same products.
  - In cases involving brand licensing or contract manufacturing (Maklun):

- o The foreign producer or its official representative may apply for the **SNI certificate**.
- The domestic brand owner, the representative of the foreign licensor, the contract manufacturer, or their authorized representative may apply for the SPPT SNI.
- Article 69 is amended to read :

This Ministerial Regulation shall enter into force on 20 May 2026.
