This addendum concerns the notification of the Ministerial Decree No. 245/2025 (4 pages, in Arabic) that gives the producers and importers a six-month transitional period to abide by the Egyptian StandardES 4986-1 "Rolling bearings — Internal clearance — Part 1: Radial internal clearance for radial bearings"; (17 page(s), in English).

It should be noted that the draft of this standard was formerly notified in G/TBT/N/EGY/511 dated 10 January 2025.

Worth mentioning is that this standard adopts the technical content of ISO 5753-1:2009 (confirmed in 2021).

Producers and importers are kept informed of any amendments in the Egyptian standards through the publication of administrative orders in the official gazette.
