This addendum concerns the notification of the Ministerial Decree No.245/2025 (4 pages, in Arabic) that gives the producers and importers a six-month transitional period to abide by the Egyptian Standard ES 9107 "disposable nursing pad"; (13 page(s), in Arabic)).

It should be noted that the draft of this standard was formerly notified in [G/TBT/N/EGY/492](#) dated 4 December 2024.
