**Description:** Products covered: Rolling bearings (ICS code(s): 21.100.20)

This addendum concerns the notification of the Ministerial Decree No. 245 /2025 (4 pages, in Arabic) that gives the producers and importers a six-month transitional period to abide by the Egyptian Standard ES 4986-2 "Rolling bearings — Internal clearance — Part 2: Axial internal clearance for four-point-contact ball bearings"; (8 page(s), in English).

It should be noted that the draft of this standard was formerly notified in G/TBT/N/EGY/510 dated 10 January 2025.

Worth mentioning is that this standard adopts the technical content of ISO 5753-2:2010 (confirmed in 2020).

Producers and importers are kept informed of any amendments in the Egyptian standards through the publication of administrative orders in the official gazette.
