Description: Products covered: Fish and fishery Products (ICS 67.120.30)

This addendum concerns the notification of the Ministerial Decree No. 248 /2025 (2 pages, in Arabic) that gives the producers and importers a six-month transitional period to abide by the Egyptian Standard ES 414-2 "Canned Shrimps and Canned Crab Meat – part 2: Canned Crab Meat" (13 pages, in Arabic).

It should be noted that the Ministerial Decree No. 1001/2017 (2 pages, in Arabic) which was formerly notified in G/TBT/N/EGY/34/Add.1 dated 10 January 2018 and the Ministerial Decree No. 93/2013 (4 pages, in Arabic) which was formerly notified in G/TBT/N/EGY/34 dated 30 April 2013, mandated among others the earlier versions of this standard.

Worth mentioning is that this standard complies with Codex Standard CXS 90 "Canned Crab Meat", adopted in 1981, revised in 1995, amended in 2011, 2013, 2016, 2018 and 2024.
