Description: As required by the Paperwork Reduction Act of 1995 (PRA), the Consumer Product Safety Commission (CPSC or Commission) announces that the Commission has submitted to the Office of Management and Budget (OMB) a request for extension of approval of information collection requirements associated with the Safety Standard for Automatic Residential Garage Door Operators. OMB previously approved the collection of information under control number 3041-0125. OMB's most recent extension of approval will expire on 30 September 2025. On 23 June 2025, CPSC published a <u>notice</u> in the Federal Register (notified as <u>G/TBT/N/USA/1029/Add.4</u>) to announce the agency's intention to seek extension of approval of the collection of information.
