Profile of Bangladesh Leather Industry

BANGLADESH LEATHER SECTOR:

At a glance

- Bangladesh government has identified leather sector as a thrust sector for export and to exploit full potentialities of this sector.
- Hides & skins of Bangladesh have well reputation and good demand in world market for its fine fiber structure and good grains.
- The annual supply of hides & skins in the country is over 220 million sq. ft. consisting of 64.83% cow hides, 32.74% goat skin, 1.09% sheep skin & 2.19% buffalo hides.
- Less than 50% of the total stock is required to meet domestic demand and the rest is exported. The main export destinations are Hong Kong, Italy, Korea, Japan, China, Vietnam, Spain, UK, Germany, France, USA, Saudi Arabia, Malaysia, etc.
- More than 200 tanneries are producing crust leather and finished leather.
- 20% of their total product meets the demand of the domestic footwear and leather goods manufacturing industries. Rest 80% is exported to different countries.
- Bangladesh is a potential offshore location for leather, leather goods & footwear products manufacturing with competitive cost.
- Quality of cow hides is of unique feature with regard to grain patterns, fiber structure (texture) etc.
- Largest tanneries / Shoe industries are well equipped and they undertake regular R&D work and product development activities.
- Relatively convenient access to supply of new types of finished leather for new shoe line.
- Easy import regulation for tannery chemicals and other items (Bonded warehouse facilities available).
- Lower level of labor costs.
- Relatively less-lead time.
- Products enjoy GSP facilities in many countries.
- Price structure is quite competitive.
- Shipment facilities (both by Air & by Sea) are adequate.
- Supply for fairly high quality of soling materials NR (Natural Rubber based) and PVC are locally available.
- Sheepskins are available for specialized lining and other purposes.
- New leather processing Zone will facilitate accelerated industrial performance in an Environment- Friendly working area.
- In Bangladesh there are 74 mechanized leather product enterprises of which 10 are engaged in producing leather goods like ladies bag, wallets, belts, leather covers for camera, laptop, leather suitcases etc. and 64 are footwear enterprises with an annual production capacity of 32.2 million pairs, average 2.7 million pairs approximately per month.
- In addition, there are 4,500 small footwear enterprises producing additional 146.6 million pairs on annual basis

Bangladesh Finished Leather, Leathergoods and Footwear Exporters' Association (BFLLEFA) as an Organization

Bangladesh Finished Leather, Leather goods and Footwear Exporters' Association (BFLLEFA) as a trade organization was first granted licence by the government on 02.03.1986 under the title "Bangladesh Finished Leather Exporters' Association". Subsequently, in 1994, it was renamed as Bangladesh Finished Leather and Leather goods Exporters' Association. Finally, in 1999, through another amendment, the organization assumed the present title - Bangladesh Finished Leather, Leather goods and Footwear Exporters' Association. The said amendments not only expanded the title of this organization but also broadened its role in rendering services to its members increasingly included from new sectors of production.

The notable aims and objectives of the association are:- to promote, protect and safeguard the interest of all members ; to maintain the highest unity, mutual co-operation and good will among the members ; to render possible help and assistance in overcoming their difficulties ; to promote or oppose legislative measures affecting the business of the members; to maintain liaison with different government departments, FBCCI and other related organizations for the protection of the lawful cause the members and so on.

BFLLEFA carries out its activities through an executive committee of 13 members elected by the general members for a term of two years. The committee again elects from itself the following office bearers.

At present the total number of members stands at 110 of whom about 30 are engaged in producing various kinds of leather goods and footwear. The rest of the members are producing superior quality crust and finished leather to boost the export earning of the country as well as to meet the domestic demand of the leather goods manufacturing industries.

Leather Sector Business Promotion Council (LSBPC):

Our Partner for Promotion

Export policy 2003-06 recognized formation of sector/product-based business promotion council (hereinafter mentioned as Council) for export promotion and diversification through addressing problems related to capacities of the industry in particular. In this connection, Leather Sector Business Promotion Council (LSBPC) was established on February 2004 under the Ministry of Commerce to promote the export of leather and leathersgoods of Bangladesh. It is a unique initiative of private – public partnership under the companies Act 1994. Members of the company represent trade associations and chambers, banks and relevant government ministries. It is working for the promotion of export of leather, leathersgoods, and footwear through organizing different capacity building activities, helping the industry to acquire right technology, and address issues related to productivity, quality, finance, standard and compliance.

Aims and objectives:

The major objectives for which it was established are:

01. To promote export of leather, lather footwear, leather products and their components;
02. To facilitate import of raw material, know how, resources, equipment, and machinery required for promotion of export of leather and leathersgoods;
03. To encourage and assist in the balanced development of leather sector in Bangladesh;
04. To promote increase and maintain the industrial utilization of slaughterhouses and leather and leather industry by products/wastage like bristles, fleshing, shaving, intestines, blood, cat guts, buffs, goats and cow tail hairs, preserved/stuffed specimen of birds;
05. To promote and disseminate useful information on leather sector and allied industries so as to enhance the contribution of the sector to the growth and development of the national economy;
06. To promote, protect and safeguard the interest of all the members of the council representing the leather sector;
07. To act as a clearing house and information Centre for members of the Council and to provide common services for their common benefit;
08. To maintain liaison with any agency setup for grading or laying down the standard of quality and packing in respect of leather & leather products intended for export;
09. To make such recommendation and suggestions to the Government as may be necessary or expedient to the development, production and sales promotion of the leather sector;

10. To undertake all measures as may be necessary to assist, support, promote and improve production of leather & leather products for export;
11. To work with the government, semi-government, private and industrial agencies with participatory approaches;
12. To make the government, and other agencies aware of and be responsive to the needs of the leather industries for healthy and rapid economic growth;
13. To develop linkage with different institution/enterprises home and abroad for the development of the leather sector;
14. To send trade mission to, or receiving such mission from, foreign countries;
15. To provide legal support / advice to the members of the Council as well as of the industry;
16. To ask the government and other authorities in framing appropriate Tax & Tariff policy and also to make change in laws and practices conducive to the growth and development of leather sector;
17. To frame and monitor a code of business ethics and general standard of business conduct and practices and promote fair competition and healthy trade practice amongst the leather industries;
18. To help in the development of human resources required by the leather sector;
19. To undertake training or educational program and consultancy to develop, promote, advance and increase the value added products in the leather sector;
20. To set up and assist to set up a common facility center/institute for testing training, standardization and design center for upgrading the technology in the leather sector;
21. To study, carry out and sponsor research /study on problems and prospects of the leather sector;
22. To undertake project and to provide facilitation service to all stakeholders in planning, implementation and evaluation of development project;
23. To edit, print and publish journals, book, brochures, flays and services of the Council as deemed expedient and in particular by circular, purchase and exhibition of works of interest, by publication of books and periodical or any other kind of literature and by giving prizes, awards and donation;
24. To enlist the service of experts and to have expert advice on matters relating to the leather sector; and
25. To undertake and settle all matters of dispute either between the Council members or between the members and others by arbitration or otherwise in accordance with the main objectives of the association.

Leather sector: History of development

Leather processing is an old manufacturing sub-sector in Bangladesh with a long heritage of over six decades. Availability of indigenous raw material (hides and skins) facilitated the setting up of the industry in early 1940s in the then East Bengal. During Pakistan period (1947-1971), the industry was dominated by non-Bangalee migrants from India, who had the knowledge and the know-how of leather processing industry. At that time, leather processing was limited to the production of wet blue leather (semi-processed tanned leather) and the non- Bangalee traders exported a large part of the product to West Pakistan for further processing and production of leather goods. A few small tanning units belonged to Bangalee entrepreneurs who processed leather mainly for the domestic market.

After the independence of Bangladesh, the government took over the tannery industry abandoned by the departing non- Bangalee entrepreneurs but had limited success in operating them under the public sector. Export of processed leather consisted almost entirely of wet blue leather till 1980-81. After 1981, a number of policy support measures aimed at privatization of and raising value addition level in the industry provided incentive for new private investment in leather industry. The ban imposed on export of wet blue leather in June 1990 led to the setting up of modern leather tanning units for the production of crust leather (tanned leather after further processing of wet blue leather) and finished leather and this was followed by new investment in leather goods industry.

About 95% of leather and leather products of Bangladesh are marketed abroad, mostly in the form of crust leather, finished leather, leather garments, footwear and leathergoods like office bags, ladies bag, wallets, belts, purses etc. Most of these items are exported to Germany, Italy, France, Netherlands, Spain, Russia, Brazil, Japan, China and Singapore. Value addition in these items is on an average 85%. About 200 TANNERY units are now in operation in this sector. These are located mostly in the Hazaribagh area of DHAKA city. In 2011-12 FY the export earning of this sector was about 430million US dollar. Nearly 270 million sq. ft crust and finished leather is exported every year. Bangladesh's share in the world leather market is 2%.

Bangladesh is endowed with luxurious vegetation encouraging a large livestock population. The quality of the raw hide and skin is relatively good, as barbed wire fencing that damages the skins of animals is not used in the natural farms and fields. Skin of black Bengal goat is particularly noted for its fine grain structure and tensile strength. The tradition of humane care of domestic animals also contributes significantly to the high quality of leather in Bangladesh.

About 40% of the supply of hide and skin comes from animals slaughtered during the annual Muslim festival of EID-UL AZHA. In addition, daily consumption of meat in festivals, Muslim weddings, and other celebrations yields a substantial supply of hide and skin. The tanning industry got a big boost following the government decision to promote more value addition in exports. The installed capacity for crust leather production increased. At present, it is double than the domestic supply of raw hide and skin. Investments are also being made in installing new finishing capacity. The trends encourage more tanneries to produce finished leather on a commercial basis.

The government of Bangladesh provides a support to the leather industry through various steps, including monitoring the export market, evaluating the performance of the sector by a permanent parliamentary committee, and liberal bank credit.

During the 1990s, the export market for Bangladeshi leather grew at an average of 10 - 15% per annum. Fine grain leather of Bangladesh enjoys preferential demand in Western Europe and Japan. Low wage level and the ban on exporting wet blue leather helped the industry receive a new thrust in the country. Environmental concerns arising out of the high concentration of production units in a small area of the older part of Dhaka city are going to be addressed with plans for their relocation outside the city.

Leathergoods & Footwear sub sector in Bangladesh has been experiencing a sharp and sustained growth during last 10 years and has started to make deep penetration into the international market. The quality and finishing of leather available in Bangladesh have been recognized globally especially in the Far East and Europe.

Export earning from finished leather, leather goods and footwear during fiscal year 2011-2012 was US\$336.31, 92.47 and 334.98 million US dollar respectively.

This sector is also a major employer of semi-skilled workers, which is a vital step towards alleviating unemployment. Information obtained from a number of credible sources exhibits that in total (accumulated) 741,000 people are employed directly and indirectly in leather and its allied sectors. 200,000 people are involved in raw hide collection and supplies 50,000 are working in tanning industry. About 300,000 workers are associated with retailing of leather and leather goods. About 150,000 persons are employed in the footwear industry, 30,000 persons are in leather goods industry and another 8000 persons are involved in exporting of leather and by-product processing. (Source: BCLT, LSBPC, OLO, BBS, GTZ, RSMA, AND ITC- ATF). Despite having a great potential for growth, the net result of development efforts undertaken for the leather sector of Bangladesh have not been impressive due to the poor quality of processing, illegal export to India, poor technologies base, inadequate financing, low value addition, lack of marketing skill, incorrect planning and improper implementation. At present leather and leather products are exported to about 53 countries of the world. The major importing countries are: Italy, Germany, Brazil, Singapore, china and the USA.

Contribution of leather sector in the country's economy

Leather and leathersgoods industries have a significant role to play in the country's economy. The development of leather and leather products sector has a high priority in terms of indigenous raw material based industry. The income generated by this sector is of significant relevance to the National economy. Even more so as the leather industry processes locally available raw material (hides and skins, by products of meat industry) into leather. Leather itself is one of the main inputs for the low investment, labor intensive leather products industry viz shoes, garments and leathersgoods for export market.
